## **CITY COUNCIL EMERGENCY MEETING**

NOTICE IS HEREBY GIVEN that the Lago Vista City Council will hold an **Emergency Meeting** on Wednesday, March 25, 2020, beginning at 5:30 p.m. to address the following imminent threat to public health and safety or reasonably unforeseeable situation necessitating this emergency meeting: a local state of disaster for the City due to public health emergency caused by the coronavirus disease 2019 (COVID-19) and Travis County Order No. 2020-5 issued on March 24, 2020 requiring, among other things, that all individuals currently living in Travis County shelter at their place of residence, all businesses operating within Travis County except Essential Businesses cease all activities within the County; and prohibiting all public or private gatherings of any number of people outside a single household.
